In addition, Mr. Murray has assisted companies in several industries, including communications, in reviews by CFIUS as well as in the similar review process conducted by the Team Telecom agencies in conjunction with transactions requiring approval by the Federal Communications Commission.

Prior to joining the firm in 2014, Mr. Murray was a partner in the communications group of a global, Am Law 100 law firm. Following law school, he clerked for Judge Frank Mays Hull in the United States Court of Appeals for the Eleventh Circuit and for Judge Louis F. Oberdorfer in the United States District Court for the District of Columbia.
